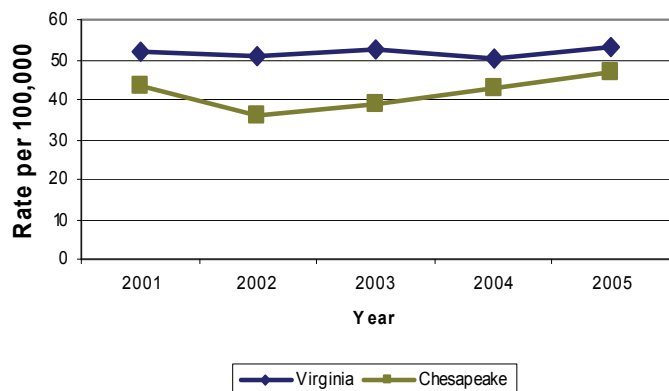


During 2001-2005, 408 injury related deaths occurred in the Chesapeake Health District.

Injury Related Deaths, 2001-2005

Demographics (age, gender, race)

- Males were more likely than females to die from injuries across every age group except those 1-4 years old (see Figure 2).
- The elderly (65 and over) experienced a higher number of injury deaths than any other age group. 34% of these deaths were the result of falls, 15% were the result of suffocation, and 13% were the result of motor vehicle traffic crashes.
- Overall, White injury death rates were 1.2 times higher than Black rates.

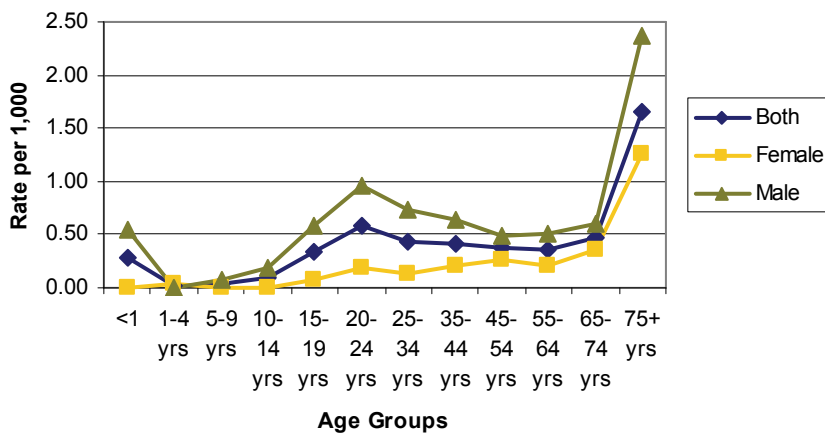
Mechanism and Intent

- 64% of injury deaths were unintentional. Motor vehicle traffic crashes (31%), poisonings (24.4%), and falls (18%) accounted for over 73% of all unintentional injury deaths.
- Suicides accounted for 20% of injury deaths. The three leading causes of suicides were: firearms (54%), poisonings (21%), and suffocation (20%).
- Homicides accounted for 15% of injury deaths. 80% of these were the result of a firearm.

Figure 2. Crude Injury Mortality Rates by Gender, Chesapeake Health District 2001-2005



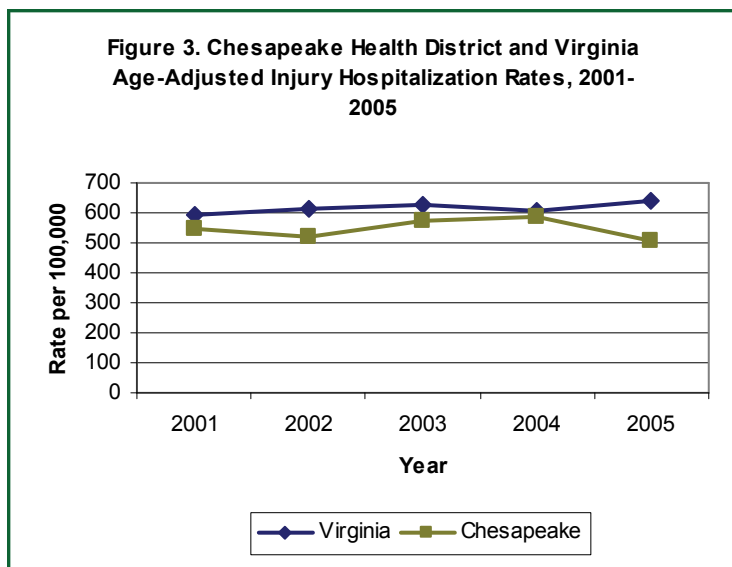

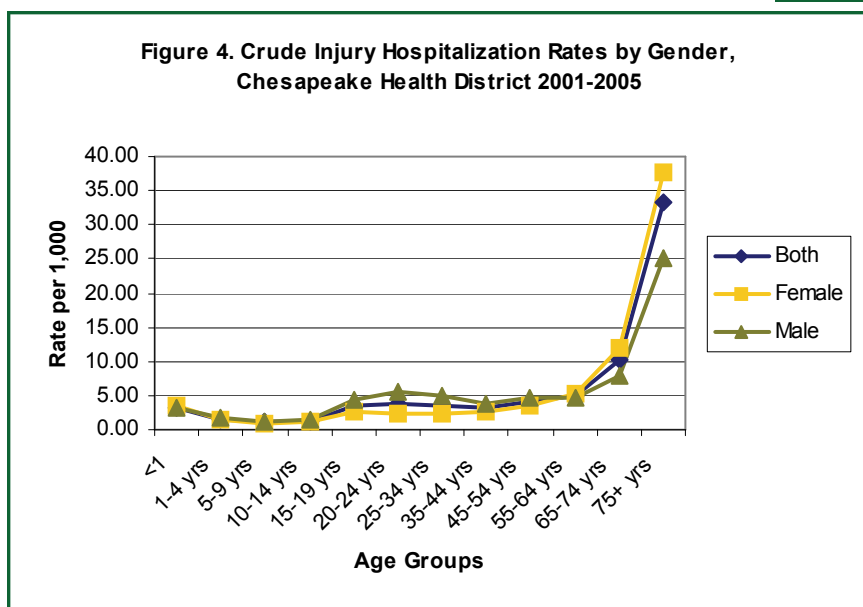

During 2001-2005, 5,037 injury related hospitalizations occurred in the Chesapeake Health District.



Demographics (age, gender, race)

- Males were more likely than females to be hospitalized for an injury across every age group except infants (<1 yr old) and those 55 and older.
- The elderly (65 and older) were more likely to be hospitalized for an injury than any other age group. 74% of these hospitalizations were the result of unintentional falls.
- Overall, White injury hospitalization rates were 1.4 times higher than Black hospitalization rates.



Mechanism and Intent

- 84% of injury hospitalizations were unintentional. Falls (51%) and motor vehicle traffic crashes (13%) accounted for over 60% of all unintentional injury hospitalizations.
- Self-inflicted injuries accounted for 9% of injury hospitalizations. Poisonings (87%) and cut/pierces (7%) were the leading causes of self-inflicted injuries.
- Assaults accounted for 5% of injury hospitalization. The three leading causes were: Firearm (28%), struck by/against (28%), and cut/pierce (13%)
