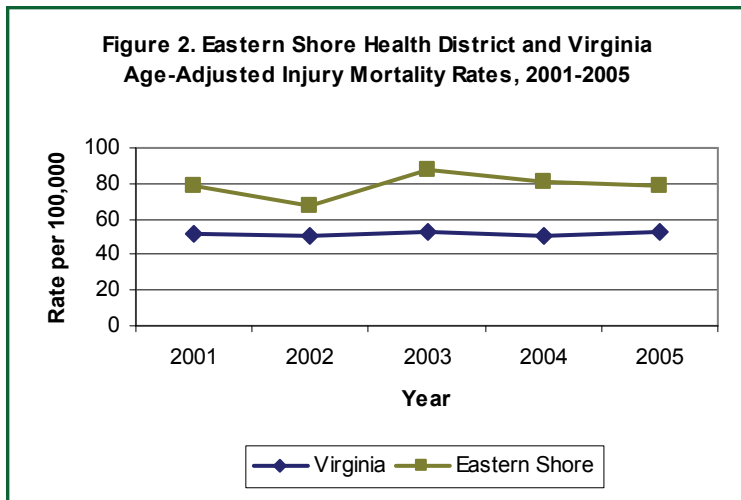


Injury Related Deaths, 2001-2005

During 2001-2005, 218 injury related deaths occurred in the two counties that make up the Eastern Shore Health District. 70% of these deaths occurred in Accomack and 30% occurred in Northampton.



Demographics (age, gender, race)

- Males were more likely than females to die from injuries across every age group except those 5-14 years old (see Figure 2).
- The elderly (65 and over) experienced a higher number of injury deaths than any other age group. 23% of these deaths were the result of motor vehicle traffic crashes and 18% were the result of falls.
- Overall, White injury death rates were higher than all other races (Black and Other).

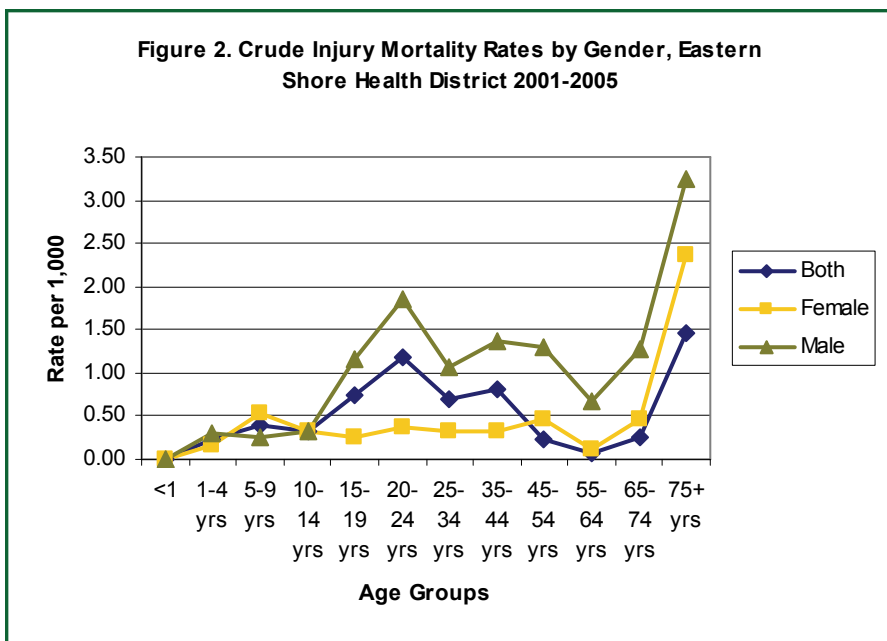
Mechanism and Intent

- 81% of injury deaths were unintentional. Motor vehicle traffic crashes (43%), poisonings (11%), and falls (10%) accounted for 64% of all unintentional injury deaths.
- Suicides accounted for 11% of injury deaths. The three leading causes of suicides were: firearms (72%), poisonings (12%), and suffocation (12%).
- Homicides accounted for 6% of injury deaths. 69% of these were the result of a firearm.

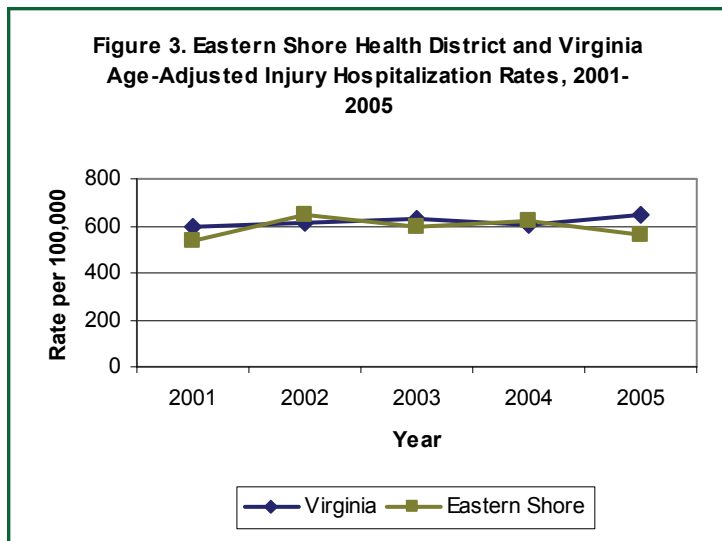

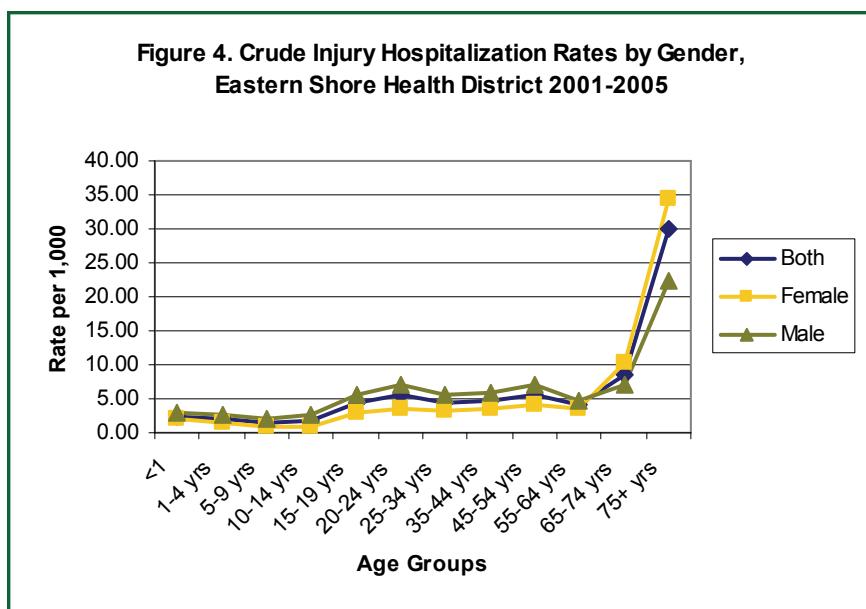

During 2001-2005, 1,726 injury related hospitalizations occurred in the two counties that make up the Eastern Shore Health District. 64% of these hospitalizations occurred in Accomack and 36% occurred in Northampton.



Demographics (age, gender, race)

- Males were more likely than females to be hospitalized for an injury across every age group except those 65 and older (See Figure 4).
- The elderly (65 and older) were more likely to be hospitalized for an injury than any other age group. 69% of these hospitalizations were the result of unintentional falls.
- Overall, White injury hospitalization rates were higher than all other races (Black and Other).



Mechanism and Intent

- 86% of injury hospitalizations were unintentional. Falls (50%) and motor vehicle traffic crashes (16%) accounted for 66% of all unintentional injury hospitalizations.
- Self-inflicted injuries accounted for 8% of injury hospitalizations. Poisonings (91%) were the leading causes of self-inflicted injuries.
- Assaults accounted for 5% of injury hospitalizations. The three leading causes were: Struck by/against (29%), firearms (14%) and cut/pierce (21%).
