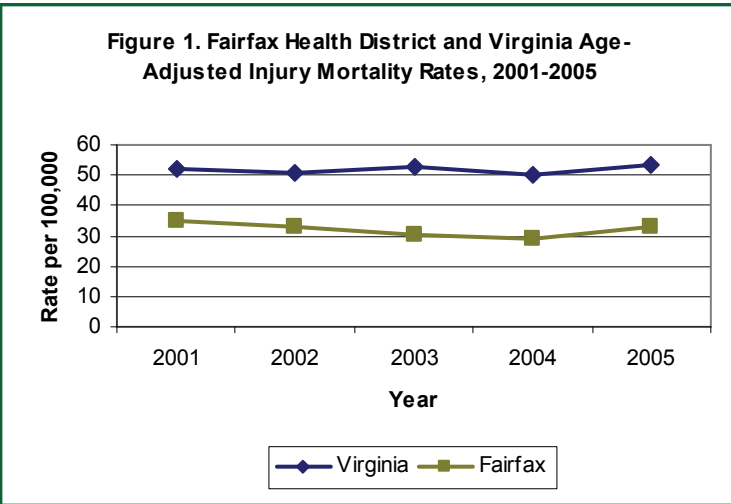


During 2001-2005, 1,440 injury related deaths occurred in the one county and two cities that make up the Fairfax Health District. 96% of these deaths occurred in Fairfax County, 3% in the city of Fairfax and 1% in Falls Church.

Injury Related Deaths, 2001-2005



Demographics (age, gender, race)

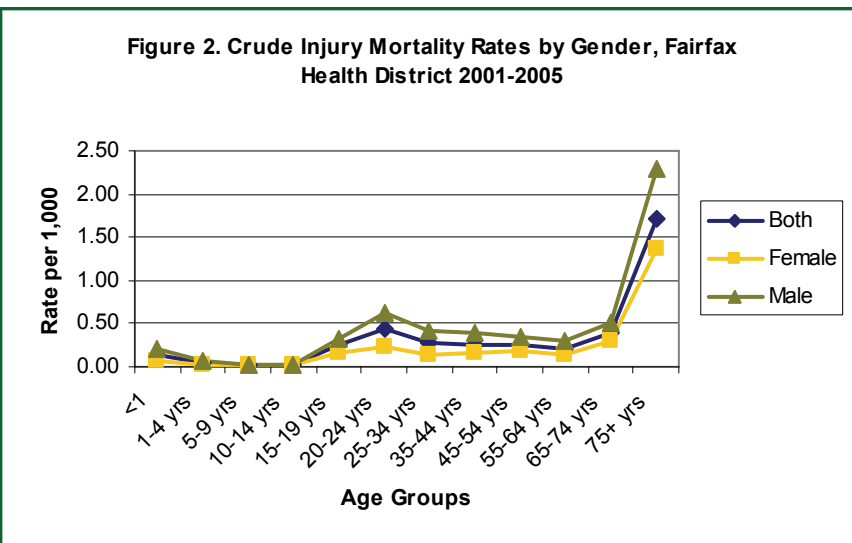
- Males were more likely than females to die from injuries across every age group except for those 5-9 year olds (see Figure 2).
- The elderly (65 and over) experienced a higher number of injury deaths than any other age group. 42% of these deaths were the result of falls, 14% were the result of motor vehicle traffic crashes, and 11% were the result of suffocation.
- Overall, White, Non Hispanics had higher injury death rates than all other race/ethnicity groups (Black, Non Hispanic; Other, Non Hispanic; and Hispanic, any race).

Mechanism and Intent

- 64% of injury deaths were unintentional. Motor vehicle traffic crashes (34%), falls (25%), and poisonings (14%) accounted for 73% of all unintentional injury deaths.
- Suicides accounted for 25% of injury deaths. The three leading causes of suicides were: firearms (42%), suffocation (28%), and poisoning (17%).
- Homicides accounted for 10% of injury deaths. The leading cause of homicide death was transportation other than a motor vehicle (38%).

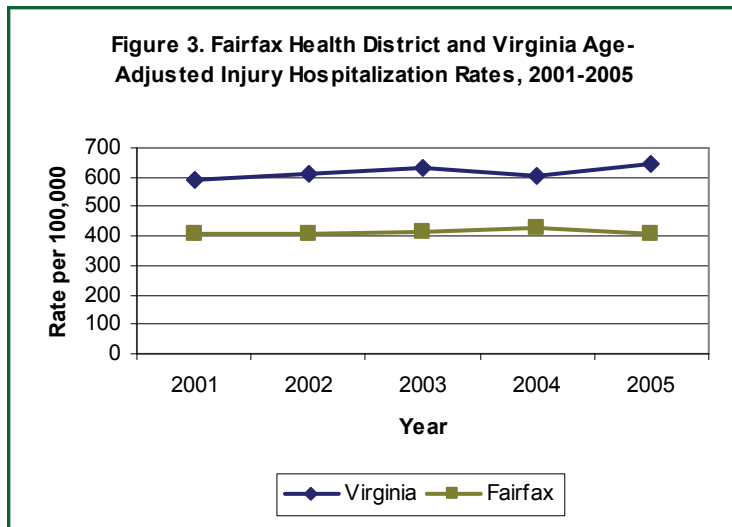

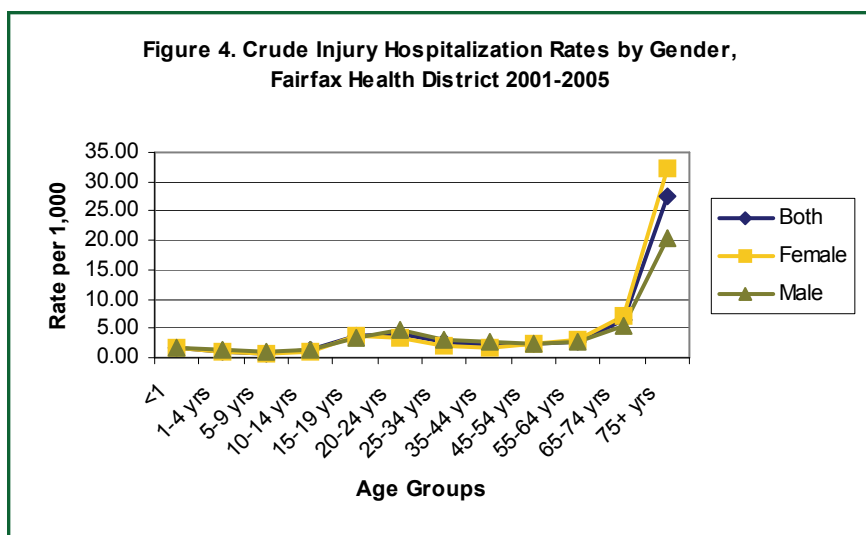

During 2001-2005, 17,794 injury related hospitalizations occurred in the one county and two cities that make up the Fairfax Health District. 93% of these hospitalizations occurred in Fairfax County, 5% in the city of Fairfax, and 2% in Falls Church.



Demographics (age, gender, race)

- Males were more likely than females to be hospitalized for an injury across every age group except infants (<1 yr old), 15-19 year olds, and the elderly 65 and older.
- The elderly (65 and older) were more likely to be hospitalized for an injury than any other age group. 79% of these hospitalizations were the result of unintentional falls.
- White, Non Hispanic injury hospitalization rates were higher than all other race/ethnicity groups (Black, Non Hispanic; Other, Non Hispanic; and Hispanic, any race).



Mechanism and Intent

- 79% of injury hospitalizations were unintentional. Falls (60%) and motor vehicle traffic crashes (14%) accounted for 74% of all unintentional injury hospitalizations.
- Self-inflicted injuries accounted for 15% of injury hospitalizations. Poisonings (83%) were the leading cause of self-inflicted injuries.
- Assaults accounted for 3% of injury hospitalizations. The two leading causes were: struck by/against (33%) and cut/pierce (33%)
