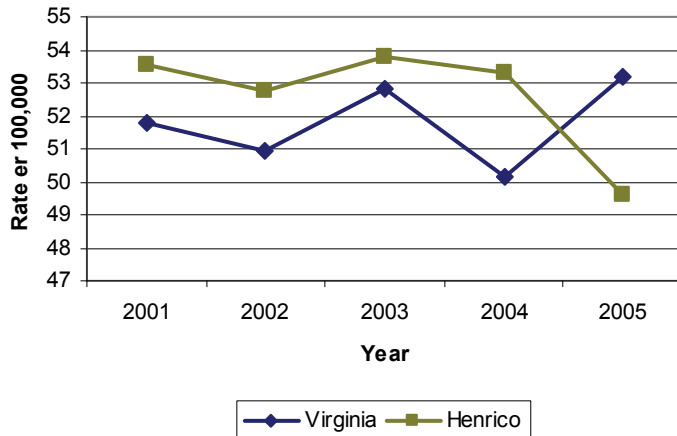


During 2001-2005, 723 injury related deaths occurred in the Henrico Health District.

Injury Related Deaths, 2001-2005

Demographics (age, gender, race)

- Males were more likely than females to die from injuries across every age group except infants (<1 yr old) and 5-9 year olds (see Figure 2).
- The elderly (65 and over) experienced a higher number of injury deaths than any other age group. 33.2% of these deaths were the result of falls, 15.3% were the result of motor vehicle traffic crashes, and 10% were from suffocation.
- Overall, White injury death rates were higher than all other races (Black and Other).

Mechanism and Intent

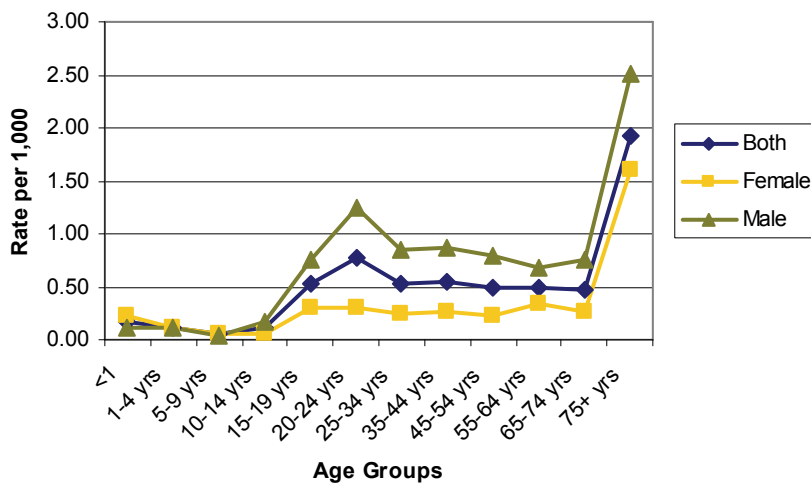
- 64% of injury deaths were unintentional. Motor vehicle traffic crashes (32%), poisonings (21%), and falls (17.3%) accounted for over 70% of all unintentional injury deaths.
- Suicides accounted for 21% of injury deaths. The three leading mechanisms of suicides were: firearms (55%), poisonings (20%), and suffocation (19.2%).
- Homicides accounted for 14% of injury deaths. 76% of these were the result of a firearm.

Figure 2. Crude Injury Mortality Rates by Gender, Henrico Health District 2001-2005

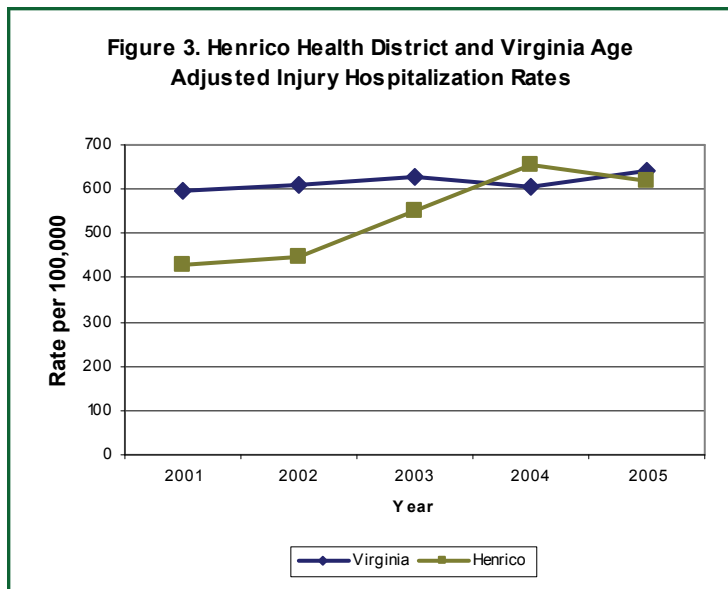

During 2001-2005, 7,419 injury related hospitalizations occurred in the Henrico Health District.



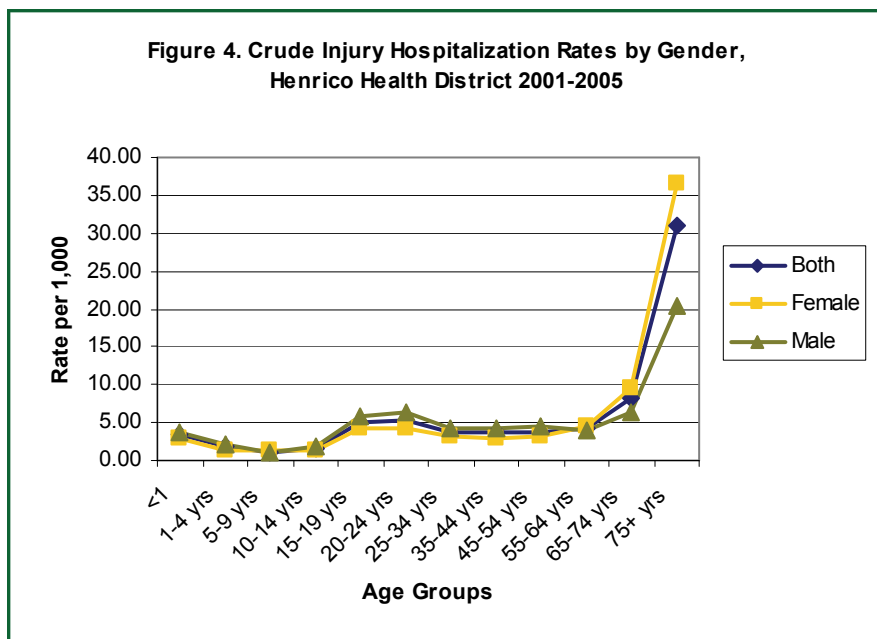
Demographics (age, gender, race)

- Males were more likely than females to be hospitalized for an injury across every age group except 5-9 year olds and those 55 and older.
- The elderly (65 and older) were more likely to be hospitalized for an injury than any other age group. 80% of these hospitalizations were the result of unintentional falls.
- White injury hospitalization rates were 1.9 times higher than Black injury rates.

Mechanism and Intent

- 80.3% of injury hospitalizations were unintentional. Falls (59%) and motor vehicle traffic crashes (14.3%) accounted for over 70% of all unintentional injury hospitalizations.
- Self-inflicted injuries accounted for 13% of injury hospitalizations. Poisonings (83.1%) and cut/pierces (12%) were the leading causes of self-inflicted injuries.
- Assaults accounted for 4% of injury hospitalization. The three leading causes were: firearms (31.3%), struck by, against (18%) and cut/pierce (15%).
