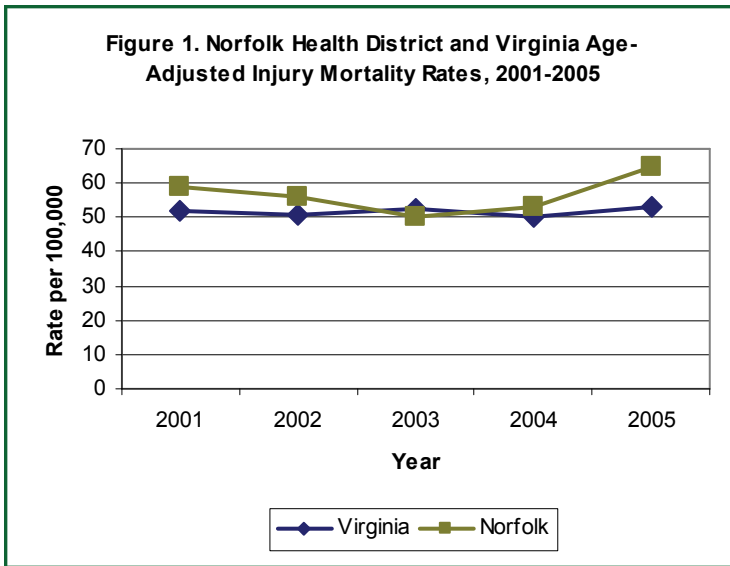


Injury Related Deaths, 2001-2005

During 2001-2005, 649 injury related deaths occurred in the Norfolk Health District.



Demographics (age, gender, race)

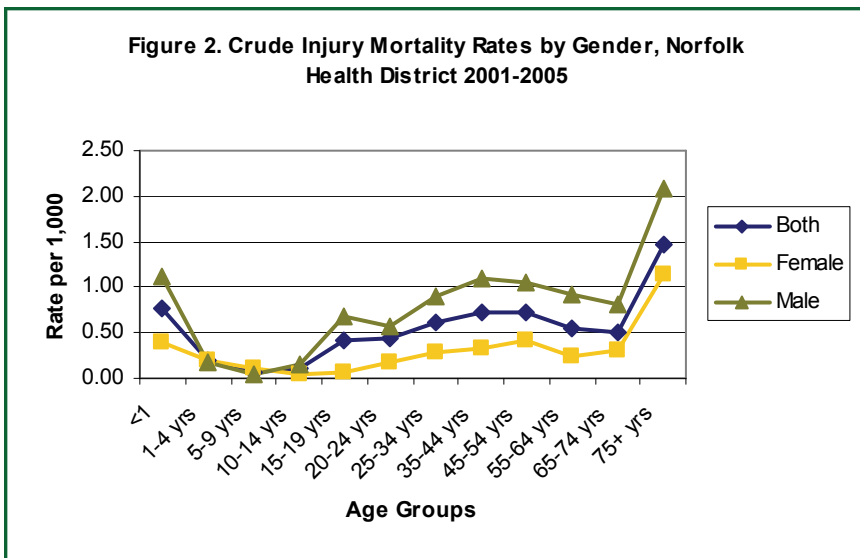
- Males were more likely than females to die from injuries across every age group except 1-9 year olds (see Figure 2).
- The elderly (65 and over) experienced a higher number of injury deaths than any other age group. 27% of these deaths were the result of falls, 15.3% were the result of firearms, and 15% were the result of suffocation.
- Overall, Black injury death rates were higher than all other races (White and Other).

Mechanism and Intent

- 50% of injury deaths were unintentional. Motor vehicle traffic crashes (25%), poisonings (23%), and falls (17%) accounted for 65% of all unintentional injury deaths.
- Suicides accounted for 19% of injury deaths. The three leading mechanisms of suicides were: firearms (56%), suffocation (25.4%), and poisoning (13.1%).
- Homicides accounted for 29% of injury deaths. 68% of these were from firearms and 11% from cut/pierce.

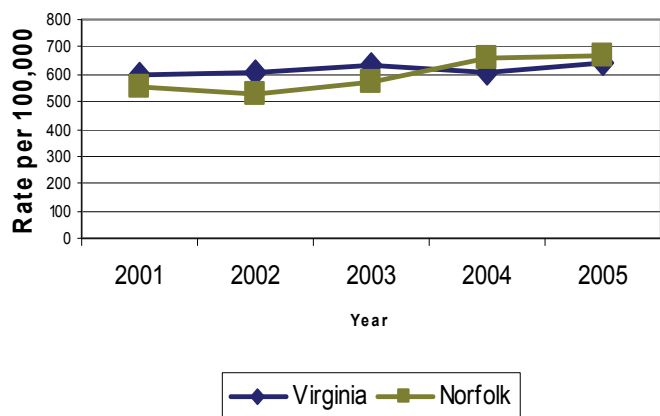

During 2001-2005, 6,524 injury related hospitalizations occurred in the Norfolk Health District.

Figure 3. Norfolk Health District and Virginia Age-Adjusted Injury Hospitalization Rates, 2001-2005



Demographics (age, gender, race)

- Males were more likely than females to be hospitalized for an injury across every age group except the elderly 75 and older.
- The elderly (65 and older) were more likely to be hospitalized for an injury than any other age group. 74% of these hospitalizations were the result of unintentional falls.
- White injury hospitalization rates were higher than all other races (Black and Other).

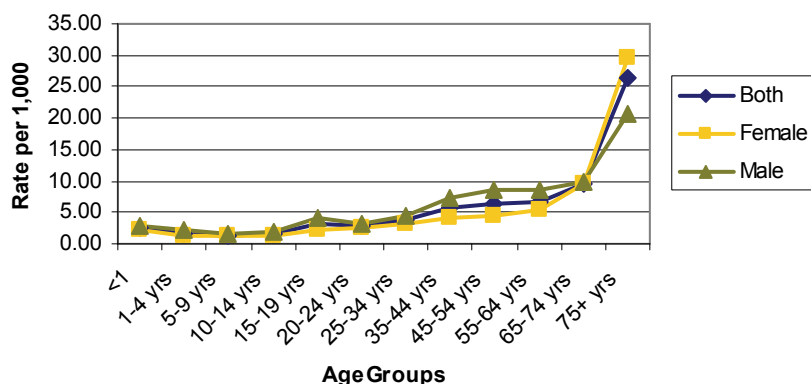
Mechanism and Intent

- 78% of injury hospitalizations were unintentional. Falls (48.3%) and motor vehicle traffic crashes (13%) accounted for over 61% of all unintentional injury hospitalizations.
- Self-inflicted injuries accounted for 9% of injury hospitalizations. Poisonings (82%) and cut/pierces (11%) were the leading causes of self-inflicted injuries.
- Assaults accounted for 11% of injury hospitalizations. The three leading causes were: firearms (30%), struck by/against (25%) and cut/pierce (16.4%).
