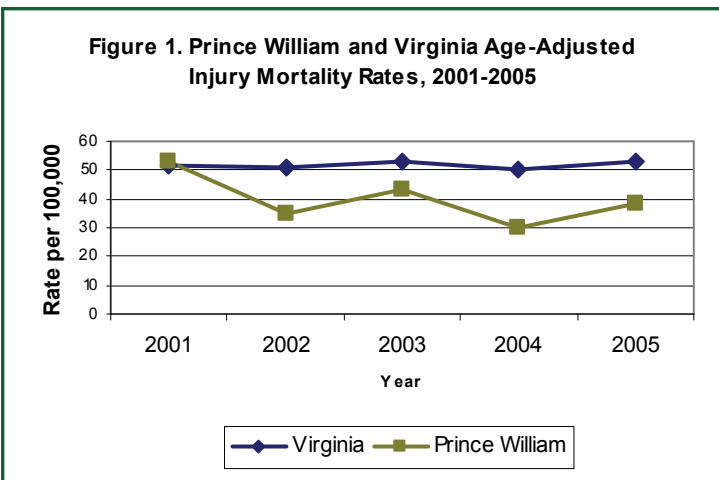


Injury Related Deaths, 2001-2005

During 2001-2005, 626 injury related deaths occurred in the Prince William Health District. 88% of these deaths occurred in Prince William, 11% in Manassas, and 1% in Manassas Park.



Demographics (age, gender, race)

- Males were more likely than females to die from injuries across every age group except infants (<1 yr old), 1-4 year olds, and those 75 and older (see Figure 2).
- The elderly (65 and over) experienced a higher number of injury deaths than any other age group. 40% of these deaths were the result of falls, 13% were the result of motor vehicle traffic crashes, and 11% were the result of firearms.
- White, non-Hispanic injury death rates were higher than the rate for all other races/ethnicities (Black, non-Hispanic; Other, non-Hispanic; Hispanic, any race).

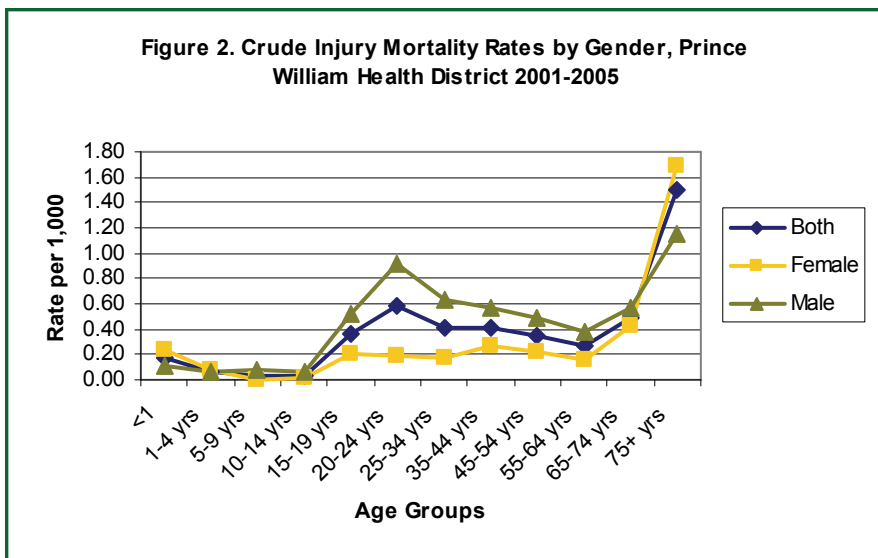
Mechanism and Intent

- 66% of injury deaths were unintentional. Motor vehicle traffic crashes (46%), poisonings (19.1%), and falls (12.1%) accounted for over 77% of all unintentional injury deaths.
- Suicides accounted for 20% of injury deaths. The three leading mechanisms of suicides were: firearms (52%), suffocation (23.4%), and poisoning (19%).
- Homicides accounted for 13% of injury deaths. 51.2% of these were the result of a firearm.

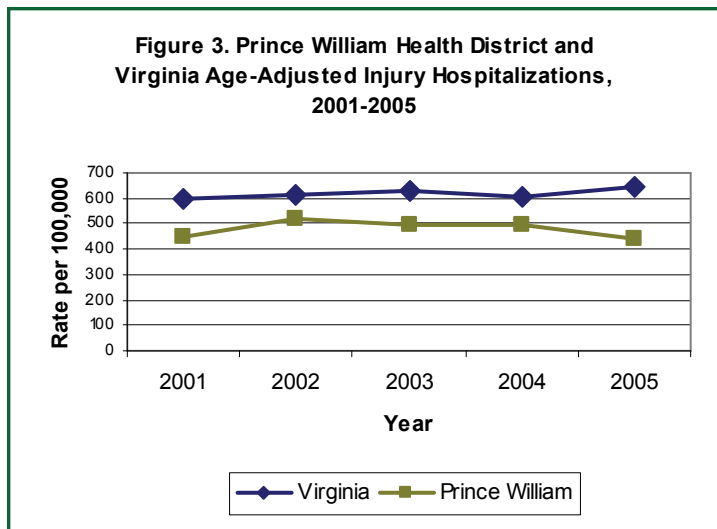

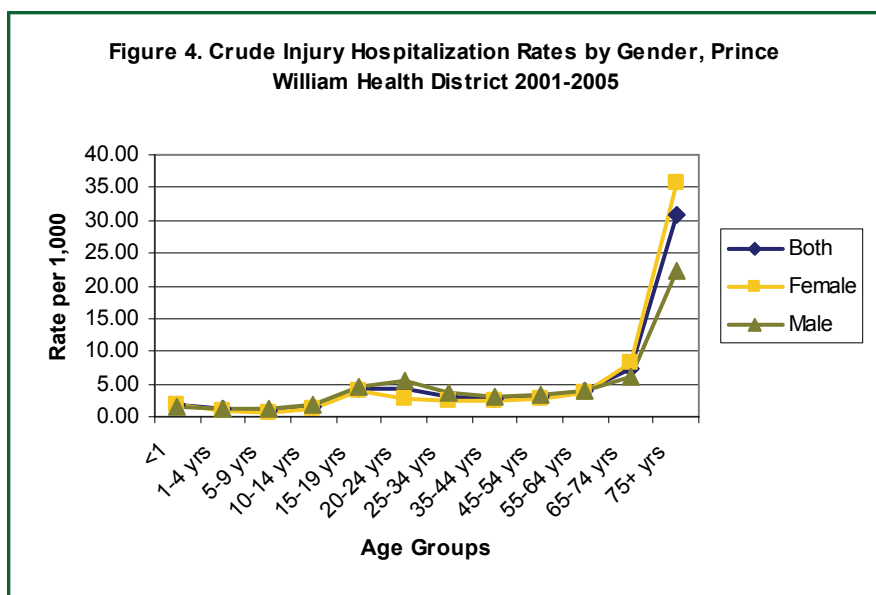

During 2001-2005, 6,434 injury related hospitalizations occurred in the Prince William Health District. 85% of these hospitalizations occurred in Prince William, 14% in Manassas, and 1% in Manassas Park.



Demographics (age, gender, race)

- Males were more likely than females to be hospitalized for an injury across every age group except infants (<1 yr old) and the elderly 65 and older.
- The elderly (65 and older) were more likely to be hospitalized for an injury than any other age group. 78% of these hospitalizations were the result of unintentional falls.
- White, non-Hispanic hospitalization rates were higher than the rates for all other races/ethnicities (Black, non-Hispanic; Other, non-Hispanic; Hispanic, any race).



Mechanism and Intent

- 77% of injury hospitalizations were unintentional. Falls (48.4%) and motor vehicle traffic crashes (19.4%) accounted for over 67% of all unintentional injury hospitalizations.
- Self-inflicted injuries accounted for 16% of injury hospitalizations. Poisonings (80.1%) and cut/pierces (16%) were the leading causes of self-inflicted injuries.
- Assaults accounted for 4% of injury hospitalizations. The three leading causes were: struck by/against (32%), cut/pierce (25.2%) and firearms (14.2%).
