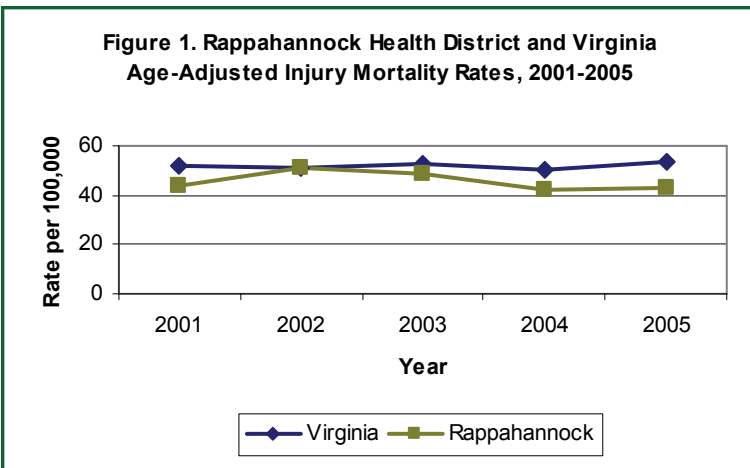


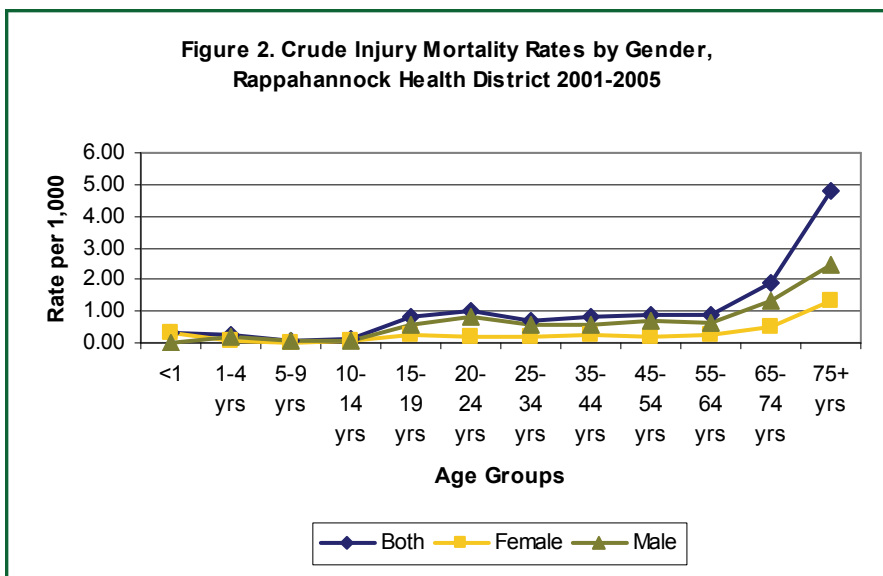
Injury Related Deaths, 2001-2005

During 2001-2005, 568 injury related deaths occurred in the four counties and one city that make up the Rappahannock Health District. The three localities with the highest percentage of injury deaths were: Spotsylvania (39%), Stafford (30%), and Fredericksburg (13%).



Demographics (age, gender, race)

- Males were more likely than females to die from injuries across every age group except infants (<1 yr old).
- The elderly (65 and over) experienced a higher number of injury deaths than any other age group. 32% of these deaths were the result of falls, 18.3% were the result of motor vehicle traffic crashes, and 15% were the result of suffocation.
- White, non-Hispanic injury death rates were higher than the rate for all other races/ethnicities (Black, non-Hispanic; Other, non-Hispanic; Hispanic, any race).



Mechanism and Intent

- 68% of injury deaths were unintentional. Motor vehicle traffic crashes (45.2%), falls (15.3%), and poisonings (9.3%) accounted for almost 70% of all unintentional injury deaths.
- Suicides accounted for 25% of injury deaths. The three leading mechanisms of suicides were: firearms (52.4%), poisonings (21.2%), and suffocation (20%).
- Homicides accounted for 6.3% of injury deaths. 50% of these were the result of a firearm.

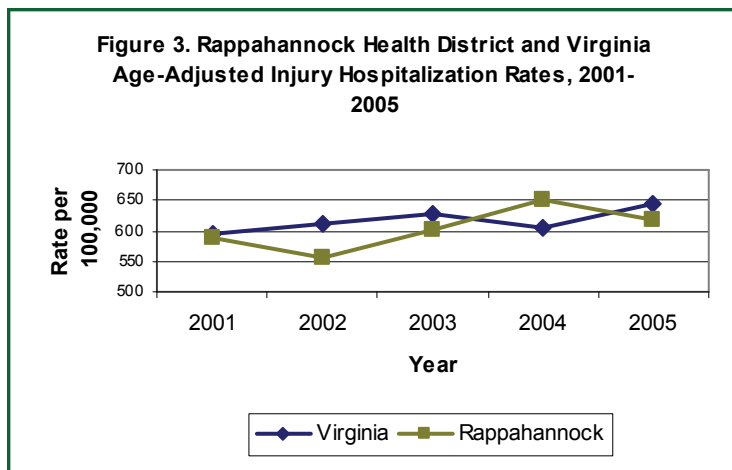

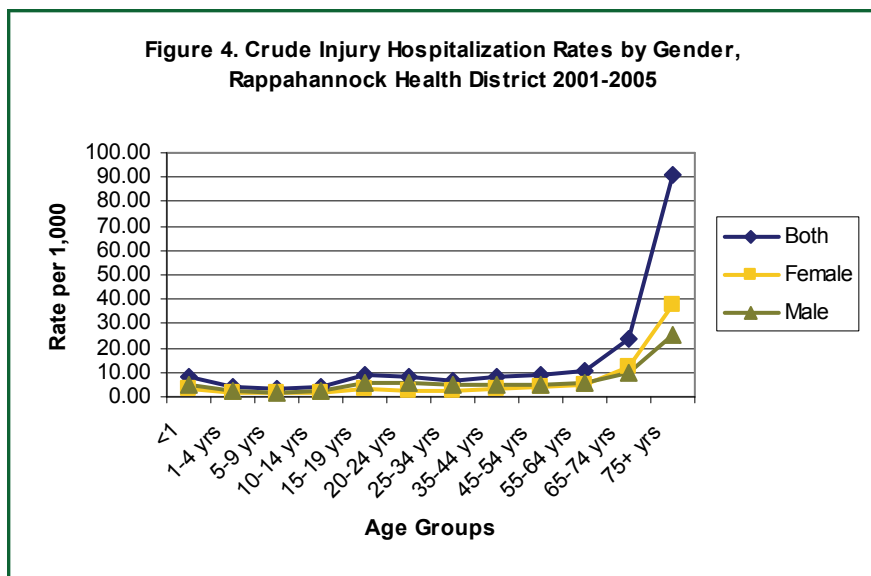

During 2001-2005, 7,140 injury related hospitalizations occurred in the four counties and one city that make up the Rappahannock Health District. The three localities with the highest percentage of injury hospitalizations were: Spotsylvania (39%), Stafford (33%), and Fredericksburg (12%).



Demographics (age, gender, race)

- Males were more likely than females to be hospitalized for an injury across every age group except for the elderly 65 and older.
- The elderly (65 and older) were more likely to be hospitalized for an injury than any other age group. 75% of these hospitalizations were the result of unintentional falls.
- White injury hospitalization rates were 1.5 times higher than Black, non-Hispanic rates, 1.7 times higher than Other, non-Hispanic, and 2 times higher than Hispanic, any race.



Mechanism and Intent

- 88% of injury hospitalizations were unintentional. Falls (48%) and motor vehicle traffic crashes (18%) accounted for 66% of all unintentional injury hospitalizations.
- Self-inflicted injuries accounted for 8% of injury hospitalizations. Poisonings (88%) and cut/pierces (7%) were the leading causes of self-inflicted injuries.
- Assaults accounted for 2% of injury hospitalizations. The three leading causes were: struck by/against (36%), cut/pierce (30%) and firearm (11%).
