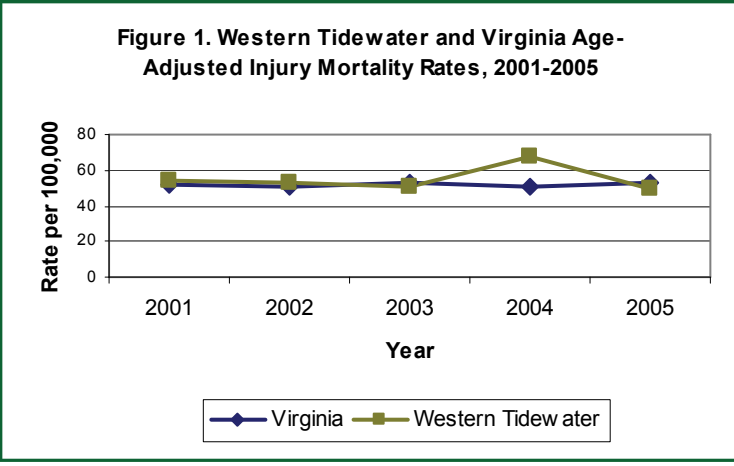


Injury Related Deaths, 2001-2005

During 2001-2005, 357 injury related deaths occurred in the two counties and two cities that make up the Western Tidewater Health District. The three localities with the highest percentage of injury deaths were: Suffolk (52%), Isle of Wight (24%), and Southampton (18%).



Mechanism and Intent

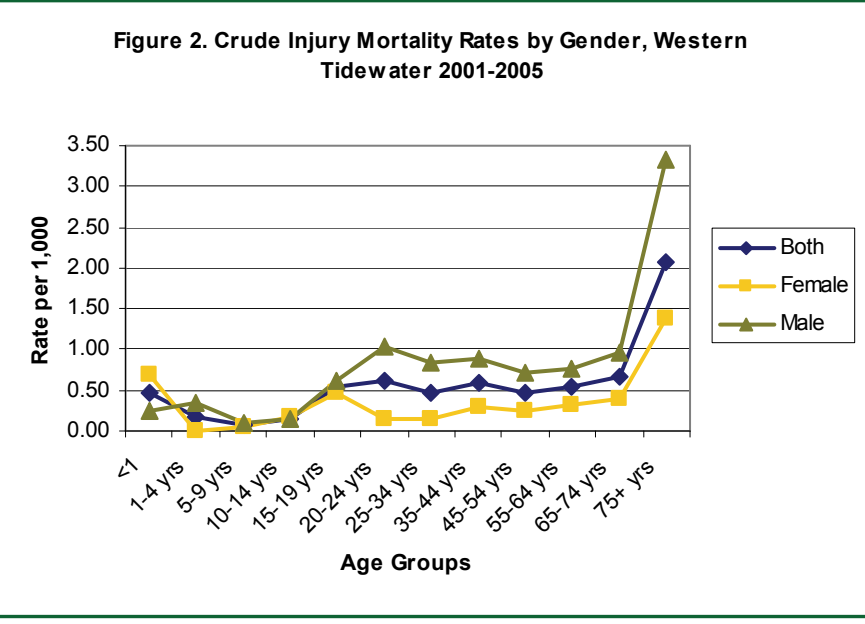
- 72% of injury deaths were unintentional. Motor vehicle traffic crashes (42.2%), poisonings (13%), and falls (10.2%) accounted for over 65% of all unintentional injury deaths.
- Suicides accounted for 18% of injury deaths. The three leading mechanisms of suicides were: firearms (73%), suffocation (17%), and poisoning (6%).
- Homicides accounted for 10% of injury deaths. 65% of these were the result of a firearm.

Demographics (age, gender, race)

- Males were more likely than females to die from injuries across every age group except infants (<1 yr old).
- The elderly (65 and over) experienced a higher number of injury deaths than any other age group. 21% of these deaths were the result of motor vehicle crashes, 18% were the result of falls, and 12% were the result of suffocation.
- Black injury death rates were higher than the rates for all other races (White and Other).

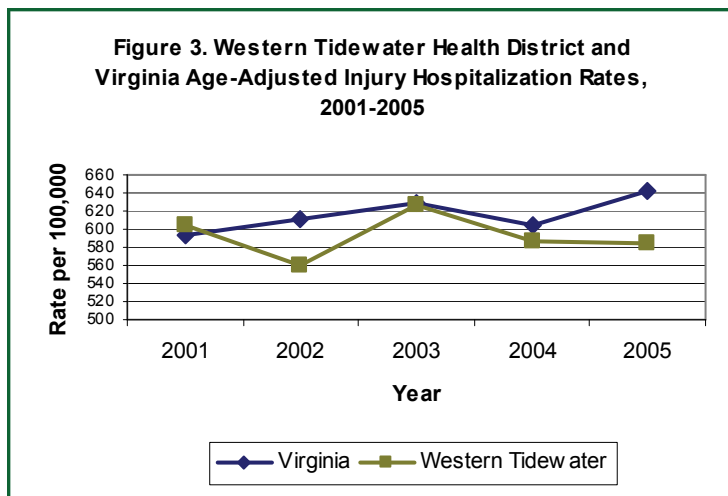

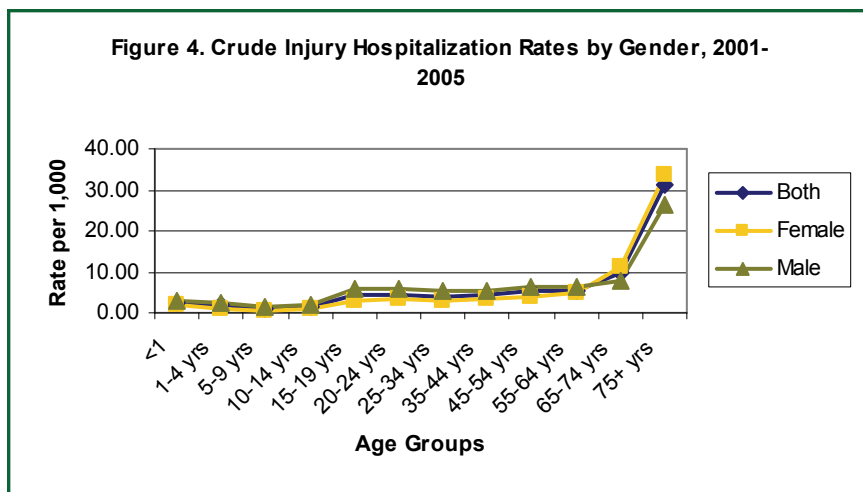

During 2001-2005, 3,809 injury related hospitalizations occurred in the two counties and two cities that make up the Western Tidewater Health District. The three localities with the highest percentage of injury hospitalizations were: Suffolk (55%), Isle of Wight (21%), and Franklin (13%).



Demographics (age, gender, race)

- Males were more likely than females to be hospitalized for an injury across every age group except for the elderly 65 and older.
- The elderly (65 and older) were more likely to be hospitalized for an injury than any other age group. 72% of these hospitalizations were the result of unintentional falls.
- White injury hospitalization rates were slightly higher than Black rates and 1.6 times higher than Other rates.



Mechanism and Intent

- 86% of injury hospitalizations were unintentional. Falls (48%) and motor vehicle traffic crashes (16%) accounted for 64% of all unintentional injury hospitalizations.
- Self-inflicted injuries accounted for 9% of injury hospitalizations. Poisonings (77%) and cut/pieces (15%) were the leading causes of self-inflicted injuries.
- Assaults accounted for 4% of injury hospitalizations. The three leading causes were: firearms (34%), cut/pierce (17%) and struck by/against (22%).
